The International Center for Research and Policy on Childhood at the Pontifical Catholic University of Rio de Janeiro (CIESPI at PUC-Rio)

The International Center for Research and Policy on Childhood (CIESPI) is a center for research and policy studies and a reference center on issues affecting children and youth, their families and their communities. Its goal is to assist the development and implementation of effective policies and practices to assist the full development of young people and the protection of their rights. The Center is particularly concerned about children who grow up in contexts of vulnerability. CIESPI operates in association with the Pontifical Catholic University of Rio de Janeiro.

Principal activities

- Developing interdisciplinary studies and social projects to contribute to the policy and practice debates and decisions in the areas of childhood, youth, families and communities.
- Organizing debates, courses and seminars to discuss and disseminate the results of its own and others' research and policy practices in Brazil and abroad.
- Convening working groups of public, university, community and non-profit actors to debate and advance improved policy priorities and agendas for children and youth.
- Disseminating research, data and methodologies from national and international studies
- Providing courses and training to students and professionals from a wide array of fields who have interests in children and youth.
- Active participation in forums, councils, meetings and events to contribute to the improvement of public policy and the implementation of children's rights.

Projects in 2018

Highlights

- Beginning of project with the Beneficent Association of the Young Nazarene which cares for street children and youth in institutions in a national project involving a study of street children and youth in ten cities.
- Continuation of the Project with the Young Nazarene on young pregnant women and mothers on the street in Rio de Janeiro
- Continuation of the project Contrasts: Listening to children and youth in the city, with University College, Ostfold, Norway.
- International research and policy on child and youth participation in public decision making organized by Ryerson University Canada in five countries

1. Knowing in order to care: a project with the Beneficent Association of the Young Nazarene



The project is collecting quantitative and qualitative data about street children who live in shelters concentrating on ten cities in Brazil with populations of over 1 million people. These cities are São Paulo, Rio de Janeiro, Salvador, Brasília, Fortaleza, Belo Horizonte, Manaus, Curitiba, Recife, Porto Alegre, Belém, Goiânia, Guarulhos, Campinas, São Luís, São Gonçalo and Maceió. The project includes a sample survey of street children on the streets, and of street children in institutional care. With the help of a group of specialist practioners the project will also develop a guide to best practices for the care of this population. Three different questionnaires are being used: a survey of services being provided in shelters and institutions, a sample survey of street youth, and a survey of street youth in institutional care about their lives on the streets and in the institutions. The surveys were conducted by field works trained by the project. The work has also included training sessions for field workers in collaboration with the *National Campaign: Children don't belong on the streets*. Local networks helped with these trainings in the ten cities.

CIESPI is responsible for the research and will analyze the profile of the young people surveyed, the services they are being offered and the characteristics of the children in institutional care including their passage from home to the streets. CIESPI will also collaborate with a group of professional organizations to put together a guide about institutional care for young people. The project will help inform Brazilian and Latin American organizations on work to improve policies and practices for these young people.



2. I am pregnant: so now what? Pregnant women and young mothers on the street



Starting in 2016, this project conducted with the Beneficent Association of Saint Martinho in Rio has already completed a first set of interviews with young pregnant women and mothers on the streets and conducted a workshop with similar young people that included discussions on gender and affectivity; exercising motherhood and fatherhood; conflict with the law; exercising rights; female health care; breast feeding, and sex and drugs. At the same time, the Rio Children’s Network organized an online course “May I speak” with the object of acquainting more people of the reality of street children’s lives and encouraging a discussion of their lives among young people.

In the current stage of the project, the team from the two organizations are conducting a survey of the service centers run by Saint Martinho in the Rio districts of Lapa and Central City, a profile of youth living in around those centers, and the needs of the young women in relation to pregnancy and maternity. This survey will also include the situation of young people occupying or “squatting in” otherwise unoccupied buildings.

Both organizations will use the learning from the project to help develop and promote better policies for young pregnant women and mothers on the streets.

3. Between home, the streets, and institutions: Children and adolescents in the situation of the streets and youth institutions in the State of Rio de Janeiro

With the assistance of FAPERJ, the State of Rio de Janeiro Foundation for Scientific Studies



The goal of this project is an analysis of the institutional care of street children and youth

in the State of Rio de Janeiro. In 2017 project staff conducted an analysis of the national literature on the topic including public policies and government plans and practices.

In 2018, CIESPI published the results of the research literature reviews, and a separate report on government policies and practices. It also identified all the institutions that cared for street children in the state. The Institute organized an open seminar “Violence in context: the dilution of rights and forms of resistance”.



4. Public policies and the struggle of implementation: the case of the policies for caring for street children in Rio de Janeiro



This four-year project had the goal of analyzing what factors helped and hindered the implementation of the Policy for Street Children in Rio de Janeiro passed in 2009. In the final project year of 2018, CIESPI published two studies summarizing the project’

- a) The struggles of implementing public policies for children and adolescents in the situation of the streets: A guide
- b) A summary of recent studies of street children and adolescents in Brazil



5. Monitoring the processes of youth participation in policies and programs for youth protection in Canada and internationally



CIESPI is the Brazilian partner in a project organized by Ryerson University in Canada involving seven universities and the five countries of Canada, Brazil, China, Scotland and South America. The project continues CIESPI's long involvement in the topic of youth participation in public debates about policies, an activity mandated by the UN Convention on the Rights of the Child. The project involves case studies of youth participation in four of the countries including Brazil. CIESPI is monitoring as a participant observer mandated youth participation in Children' Rights Councils particularly in the cities of Rio de Janeiro and Volta Redonda.

6. Childhood without violence: a goal for Rio



CIESPI has long been concerned with the long-term negative effects for children of growing up in overcrowded, violent and unhealthy communities. This project, in partnership with the Bernard van Leer Foundation, aimed to research and put into action strategies to reduce violence and improve the conditions of small children (0 to 8 years old) living in low-income neighborhoods, and expanding opportunities for their full development. In the initial years, CIESPI conducted a population and a sample survey of safe places for young children to be in the communities of Rocinha and Parada de Lucas, concentrating in particular what assistance early childhood centers needed to improve their services to

young children and to expand. In 2018, the last year of the project, CIESPI and community colleagues in Rocinha launched a pilot campaign to dramatize the plight of children 0-8 in the community and to develop priorities for change. CIESPI maintains a presence in the community on this topic as it seeks funds to expand the work.

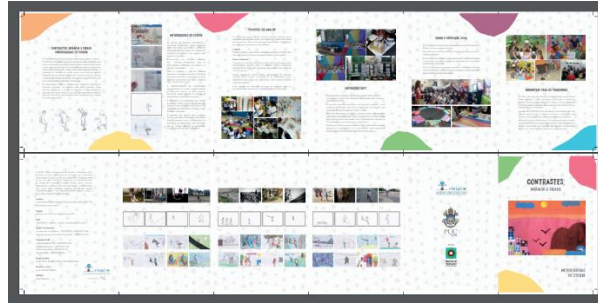
7. Contrasts: Listening to the voices of children



CIESPI has always been guided by the UN Convention on the Rights of the Child's mandate for age appropriate child participation in public decisions that affect their lives. One issue in child participation is how to listen effectively to the voices of children. Collaborating with Østfold University College (OUC) in Norway, CIESPI produced a series of photographs illustrating the variety of childhoods in Rio in particular the differences between lower-income and middle-income childhoods. These photographs have been displayed in a variety of locations in Brazil and in Norway.

CIESPI staff then started to experiment with how the photographs could be used to help teachers elicit the thoughts and feelings of their young students. They developed a method of extracting from the photographs silhouettes of the children but concealing the rest of the context of the photographs. Children in classrooms were then invited to "complete" the silhouettes turning them into drawings which helped to reveal the children's concerns about their families and communities. CIESPI and OCU have always seen the photographs and the silhouette drawings of bringing the reality of children's lives and thoughts into the public arena to inform public policy.

In the latest phase of the project, the CIESPI team, having already applied the methodology in municipal schools, is working with it in a private school in Rio. Østfold University College colleagues are doing the same in a very diverse public school with students representing twenty different language groups. In Brazil, almost twenty percent of students attend private schools and CIESPI wishes middle class children and youth to be listened to and to be exposed to issues affecting other children.

8. Enhancing cultural, play and educational opportunities for young children in low-income communities

The Play Center in Rocinha

In 2018, CIESPI, who worked with residents to establish the Play Center in the low-income community of Rocinha, close to CIESPI's offices, developed a new stage of the collaboration which included prose circles, play circles and the production of short audio-visual material for play centers. CIESPI was active with the Rio de Janeiro Points of Culture Forum's activities in the debates with 2018 electoral candidates.

The Playfulness of Memory

Starting in 2012, CIESPI became a Point of Memory working in the Rocinha community on activities to promote a dialogue between the community's memory of itself and of its history and playfulness. The project is working on three videos, the Memory of Water in the Community, the Samba which sings of Rocinha, and Playful walks.

The Lucidity of memory

CIESPI became an official Rio Memory Point in 2012. It then began to develop action and research entitled "Ludicidade da memória", the lucidity of memory, designing different activities that promote a permanent dialogue between memory and playfulness with exhibitions about the community of Rocinha. The program is a member of the Network of Memory Points and the Network of Social Museology.

CIESPI AS A REFERENCE CENTER: PROVIDING KEY DATA TO INFORM PRACTICES AND POLICIES ON CHILDREN, YOUTH AND FAMILIES

From its beginning, CIESPI has been a reference center for diverse audiences interested in data

and information that assist the task of improving conditions for children, their families, and their communities. Much information is now available on line on the CIESPI website.

Major activities

- Childhood in numbers collects and displays in accessible form key data about children, youth and families in Brazil.

This activity has been made possible in part by grants from the Oak Foundation, Geneva, Switzerland, and the Bernard van Leer Foundation, The Hague, the Netherlands.

- The Legal Database (Base Legis) is an ongoing, virtual, historical archive on Brazilian constitutions, laws, bills, and decrees on children and adolescents. It also contains international treaties, declarations, accords, and agreements on children and adolescents. Its 300 documents stretch from the beginning of the 19th Century to the present. This database is updated on a continuing basis, is open to the public, and has search capacities.

CIESPI is most grateful to the group of skilled professionals who volunteer their time to maintain this database. They are listed in the CIESPI website.
